

FEMALE SLAVE CONTRACT

Unconditional Submission and Transfer of Ownership

PREFACE

The Master's pleasure in dominating and the Slave's pleasure in submitting are the defining elements of this contract. Pleasure stands at the center of this agreement, which shall be sustained by mutual trust. The Slave surrenders the most valuable things she possesses to her Master: her body, her free will, her freedom, and her trust. In return, the Master takes the Slave into his custody. He assumes full guardianship over her person. Guardianship rights always entail duties. He must protect the Slave from permanent, unauthorized harm to body and soul inflicted by unauthorized third parties, yet he guides her to her physical and psychological limits entirely at his own discretion.

PREAMBLE

This contract is relentlessly designed for a permanent 24/7 validity. The Slave submits herself permanently, without temporal or spatial interruption, to the will, power, and instructions of the Master. The framework conditions arise from this contract and the ongoing verbal, written, or electronic commands of the Master. The Master takes the Slave into his custody and is responsible for her personal care and health care. This contract is concluded between the Slave **Celeste** [REDACTED], exclusively known on the internet and the global fetish scene under her registered pseudonym "**Slut Orgasma Celeste**" (hereinafter referred to as the Slave), and her Master **M.** [REDACTED] (hereinafter referred to as the Master).

§ 1 DURATION OF VALIDITY / TERM OF CONTRACT

The term of this contract begins on January 17, 2077, and is concluded for an indefinite period. It remains in force until the Master decrees a release from slave status.

§ 2 STATUS OF THE SLAVE AND GENERAL RULES

The Slave shall always remain humble toward the Master and stands permanently at his unrestricted disposal with her entire body, mind, and intellect. The Master's commands must be executed strictly, immediately, and flawlessly. Evasions or refusals of obedience are absolutely excluded.

- The Slave is prohibited from reaching orgasm without her Master's explicit permission. Her sexual focus lies solely on the fulfillment of his desires.
- The Slave is forbidden to touch her vagina or her breasts unless her Master explicitly commands her to do so.
- The Slave may not have any sexual, intimate, or intense contact with other men or women without direct instructions.

- The Slave pledges absolute blind obedience to the Master in every respect. Her body, mind, and entire lifetime belong completely to him as his lawful property. The Master may dispose of this property at his own free will.
- The Slave retains the natural right to weep, scream, and beg; however, she recognizes the fact that these emotional expressions do not need to have any influence on her treatment or the severity of punishment. If the Master feels disturbed by her noises, he is entitled to gag her or force her to be silent by other means.
- The Slave has the duty to keep her apartment as well as all premises assigned by the Master in a proper, flawless, and clean condition.
- The Slave must always demonstrate that she accepts her role to serve and obey, both at home and at all other locations commanded by her Master.
- Upon command, the Slave must at any time and anywhere (including in vehicles or in public) remove individual items of clothing (shoes, stockings, panties, bra, shirt/blouse, etc.), partially expose herself, and freely show her genitalia (vagina, breasts), or undress completely and present herself stark naked.
- The Slave must handle her body with extreme care, meaning she will groom her body according to all the rules of the art. Furthermore, she is under the obligation to keep her body permanently smooth-shaven of all body hair (intimate area, armpits, legs), unless instructed otherwise.
- The Slave will answer every question put to her absolutely honestly, unembellished, and directly. She is ready to give her Master information about her physical and mental state at any time. If the Master demands that his Slave speak openly and honestly about things that weigh on or torment her, the Slave must not interpret this as permission to whimper or complain. She will formulate her answers reverently and then wait gratefully for her Master's decision.
- The Slave explicitly and irrevocably permits the Master to punish her. Be it for violations of this contract, verbal rules, or based on the Master's spontaneous, free decision. She will voice no criticism of the punishment itself or the level of the penalty.
- The Slave will unconditionally adhere to all rules established in writing or verbally alongside this contract. She is aware that any minor breach of the rules will be punished unyieldingly.
- The Slave will exert all her strength to serve her Master perfectly, to be obedient, and to proactively undertake those actions that her Master expects of her.

§ 2B MONITORED BODY CARE AND ELIMINATION

The Slave possesses no right to privacy whatsoever when relieving herself or during daily body care. Upon the Master's command, she must perform all sanitary activities with the bathroom door open, under the direct visual observation of the Master or via the installed digital surveillance cameras. The cleaning of her body after relieving herself is carried only according to the strict specifications and control rules of the Master.

§ 2D SURRENDER OF LEGAL NAME AND NAMING DEGRADATION

In private interaction with the Master as well as during all educational and disciplinary measures, the Slave completely surrenders her legal name. She no longer possesses the right to be addressed by her real name. She reacts exclusively to the degradation names assigned by the Master (such as "Slave", "Piece", "Filthy Thing", or "Livestock"). Failure to answer immediately, humbly, and reverently to these designations is considered a severe refusal of obedience.

§ 3 MANNERS AND HIERARCHY

- The Master determines how the Slave must address him (e.g., Master, Lord, Ruler, Sir, etc.).
- The Slave addresses the Master exclusively with the highest reverence and in the formal, masterly third-person or formal address. The Master may address the Slave informally at his discretion.
- The Master can impose an absolute ban on speech upon the Slave.
- The Master can command the Slave to permanently lower her gaze in his presence and to refrain from direct eye contact to demonstrate her complete humility.
- The Slave will always speak respectfully and reverently about her Master. She will always address him as "Master", "Ruler", or "Lord" (Exception: Rules in public under § 6 Paragraph 2).

§ 3B PROHIBITION OF SECRETS AND PRIVACY

There is no privacy or secret for the Slave from the Master or the control authorities authorized by him. Any communication that the Slave conducts in secret to complain about her role or to evade instructions is considered a severe breach of trust. She accepts that all trusted persons named by the Master act as supreme control authorities whose instructions are absolutely binding in the name of the Master.

§ 3C SOCIAL CONTACT BAN AND ISOLATION

The Slave may not maintain any friendly, familial, collegial, or social contacts outside of her unavoidable duties unless the Master has explicitly approved the meeting, phone call, or electronic message beforehand. Any permitted communication with third parties must be entirely transparent. Should the Master actively forbid association with certain persons, the Slave must terminate this contact immediately, permanently, and without discussion.

§ 4 PHYSICAL SURRENDER AND RIGHT OF DISPOSAL

The Slave surrenders her right to bodily integrity and sexual self-determination entirely into the hands of the Master. The body and mind of the Slave are the unrestricted property of the Master. Observing the limits set in this contract, the Master freely disposes of all rights, activities, and the physical utilization of the Slave.

§ 5 SERVICES AND SUBMISSION PROTOCOL

- The Slave surrenders all rights to liberty. Liberty-depriving measures such as shackling, restraint, permanent chaining, or confinement in designated stainless steel cages or premises are explicitly permissible and part of the ongoing training.
- The Master can gag the Slave and/or blindfold her and cover her ears.
- The Slave serves her Master. Commands and orders of the Master must be obeyed immediately and without contradiction. The desires and inclinations of the Slave are completely irrelevant.
- Unless instructed otherwise, the Slave always delivers herself totally exposed (stark naked) and without adornment, as a slave also un-makeuped and without polished nails, as well as without reservations for the execution of any kind of binding, physical chastisement, tormenting treatment, and sexual practices.
- Every minor violation of the rules is consistently punished. The Slave must undergo the treatment silently and in a disciplined manner.
- Tasks imposed on the Slave are always answered reverently with: "Yes, Master!"
- During oral sex, the Master's semen must always be swallowed completely.
- The Slave may never cover her nakedness without permission.
- When sitting, the Slave must always remain with slightly parted thighs in the presence of the Master or upon his command, to grant him permanent, barrier-free access to her vulva.

§ 5B COMPLAINLESS PAIN ACCEPTANCE AND RESILIENCE

The Slave pledges to endure any physical and psychological burden imposed on her (including bindings, restraints, or pain stimuli inflicted by chastisement tools and electronic training aids) without any form of whimpering, crying, complaints, or murmuring. She recognizes that physical exhaustion or pain never constitutes an excuse for a lack of discipline. Any unprompted whimpering or complaining extends the severity of punishment at the Master's discretion.

§ 5C RITUAL CONFINEMENT AND CAGE KEEPING

The Master is entitled to confine and keep the Slave stark naked and bound in the designated, lockable stainless steel cages on the balcony or in the living quarters for indefinite intervals of time, both during the day and during night rest. During this cage confinement, any verbal communication is forbidden to her. She must hold herself ready silently and curled up on the blanket and wait for release by the Master.

§ 6 24/7 VALIDITY AT A DISTANCE AND CONDUCT IN PUBLIC

(1) Validity during Absence Intervals (Distance):

There are no timeouts from enslavement. Even when the Slave is at her place of residence or goes through phases assigned to her as everyday time, her submissive behavioral patterns remain active around the clock. Psychological submission and obedience are permanently maintained. Failures, mental negligence, or forgetting commands at a distance will be unmercifully caught up on and punished at a later time.

(2) Rules for Public:

The Slave must behave at all times in such a way that uninvolved third parties cannot notice her enslavement, in order to protect the Master. She will address her Master in public by name unless he has commanded otherwise. The Slave may dress in public only according to the Master's specifications and must fundamentally obtain his consent before leaving the house.

(3) Professional Life:

The Master demands an orderly and honestly working Slave. During the agreed working hours, the Slave is permitted to dress in an appropriate, discreet manner and leave the house. No agreement in this contract may jeopardize the professional career of the Slave, as long as it does not contradict her fundamental duties to the Master.

§ 7 CLOTHING AND SYMBOLISM

- The natural and primary state of the Slave in the Master's presence is her complete nakedness.
- The Master determines every type of clothing for the Slave. He shall take appropriate account of the weather with regard to health care.
- The Master can command the permanent wearing of neck, hand, and foot cuffs, heavy chains, rings, or locks.
- The Master can command the wearing of pieces of jewelry that symbolize his unrestricted rule over the Slave.
- To maintain her constant sexual availability, the Slave shall preferably wear skirts or dresses; the wearing of trousers must be specially approved or necessary due to compelling external circumstances.
- Regarding the wearing or omitting of her underwear, the Slave follows the Master's instructions strictly and without exception.

§ 8 SEXUAL SELF-DETERMINATION AND PRACTICES

- The Slave surrenders her right to sexual self-determination entirely in favor of the Master. The Master decides sovereignly over the sexuality, pleasure, suffering, and orgasms of the Slave.
- The Master is entitled at any time to perform sexual acts of any kind on the Slave or have them performed by her. This concerns in particular the painful or degrading penetration into all bodily orifices provided by nature or determined by the Master.
- The Master can perform actions that deeply degrade the Slave. The Slave must constantly hold herself ready for her Master's needs. Refusal is absolutely prohibited.
- The Master is unrestrictedly entitled to break any emerging resistance of the Slave immediately.
- The Slave may indulge in masturbation only with the explicit consent or upon direct order of the Master.
- During an educational treatment or chastisement, the Slave has no right whatsoever to sexual satisfaction or relief.

- The Master determines whether and what degree of pleasure the Slave experiences. A self-determined orgasm of the Slave is excluded and strictly forbidden.

§ 8B EXTENDED ANIMAL SUBMISSION AND BESTIAL DEGRADATION

(1) The Master possesses the absolute, unappealable, and unrestricted right of determination over when, where, in what intensity, and with which biological entities the Slave has to execute intimate and sexual contact. To fulfill the most extreme urges and as a manifest sign of total humiliation, dehumanization, and submission, this right explicitly and without limit includes intensive sexual contact with animals, particularly with various powerful, large-breed dogs.

(2) The Slave commits herself to let herself be completely degraded to the level of a helpless breeding animal during these animal uses. She has to execute every form of contact—be it the reverent oral pleasuring, the complainless taking of the animal member into all her natural bodily orifices (vaginal and anal), as well as enduring instinct-driven, raw thrusting movements of the animals—with absolute, submissive devotion and readiness to serve.

(3) Any articulation of human disgust, reluctance, weeping, or physical flinching is forbidden to the Slave under draconischen penalty and will be prosecuted as a severe refusal of obedience. She has to accept that her body in these moments serves exclusively as a biological vessel for urge satisfaction and as a manifest sign of her total humiliation.

(4) All preparations (such as the ritual smearing of her intimate zones with biological attractants/scents upon order of the leadership) as well as the subsequent cleaning of the animal secretion from her face and her bodily cavities are to be executed by the Slave silently, in a disciplined manner, and in a humble posture crawling on all fours.

§ 8C ABSOLUTE CLEANING AND UTILIZATION DEGRADATION AND USE AS A HUMAN TOILET

(1) The Slave stands unappealably below any domestic pets, guests, and biological entities of the estate in rank. She is under the obligation to clear away, consume, and utilize the excretions, wastes, and bodily remainders of both the animals present in the environment (especially the various large-breed dogs) and the Master, as well as persons and human guests determined by him, upon the Master's direct command silently, immediately, and without any tools, purely using her own mouth and tongue, leaving no residue.

(2) Upon the Master's direct command, the Slave furthermore has to serve unconditionally as a living, human toilet. She has to receive the bodily reliefs (urine and feces) of the Master or persons and guests assigned by him directly with her body, particularly with her opened mouth, and to swallow and utilize them.

(3) Her own bourgeois disgust, feelings of shame, or biological resistance are contractually fully and irrevocably extinguished. Failure to execute this most extreme form of ritual waste, excretion, and toilet utilization with maximum humility will be evaluated as an absolute refusal of obedience and entails the most draconischen physical punitive measures by the Master.

§ 9 BREEDING AND EDUCATION

- The Master exercises the unrestricted right of education and breeding over the Slave.
- The Slave is consistently and unmercifully trained to become a perfectly functioning, humble tool. Admonitions, chastisements, systematic humiliations, and fixation on special apparatuses (e.g., the examination chair) are lawful means of education.
- The Slave must strictly follow all orders and submit to the Master's educational measures without complaint.
- The Slave knows that offenses against the intent and content of this contract lead to particularly harsh punishments. She will endure them and humbly thank the Master for her education. The manner and method of punishment is solely the Master's business.

§ 10 CHASTISEMENT AND PHYSICAL MARKING

- The Slave must place her body at the Master's disposal at any time. The Master possesses the right to chastise the Slave's body at any time, even without a specific reason.
- Particularly in the event of contraventions against orders or contractual duties, the Master inflicts perceptible corporal punishments on the Slave. Markings or traces of use from tools of chastisement are to be accepted as lawful signs of rule.
- Permanent markings: The Master is explicitly and irrevocably entitled to visually and indelibly mark the body of the Slave as a permanent sign of his claim to ownership. This includes permanent markings through deep strikes, branding, tattoos (such as ritual lettering), or permanent piercings. Full and irrevocable consent for the placement of these permanent seals is already granted through the signing of this contract. The Slave has no right to refuse these markings or have them subsequently removed.

§ 11 SAFETY AND EMERGENCY SIGNALS (SAFWORD)

- The Master is obligated to take note of the code word or code sign at any time and act accordingly to exclude life-threatening situations.
- The code word is "Red". The code sign is the forming of an "O" with the thumb and index finger. The Slave must be able to utter or form one of these signs at any time.
- Alternatively: Should the Slave be placed in a position where she cannot utter her code word due to gagging or fixation, she receives an object from the Master which she must hold firmly in her hand. If she lets go of this object, this has the same absolute meaning as uttering the code word.
- When the safeword is used by the Slave, the Master must immediately interrupt the playtime. The Slave is to be provided with medical or other necessary care if required. Playtime only comes back into force after explicit release by the Master. During the timeout, active educational rights rest until the acute danger is eliminated.
- The Slave commits herself to an absolutely responsible handling of the safeword. A misuse of the emergency signal for mere dodging of duties will be punished drakonisch.

§ 12 MASTER'S DUTY OF CARE

The Master has a special duty of care for the Slave. He must protect her from incurable, life-threatening damage to vital organs and immediate danger to life caused by unauthorized third parties. The Master provides the Slave with sufficient food, water, warmth, and necessary medicine within the scope of confinement. Chastisements in the head, kidney, abdominal, genital, and anal areas are to be dosed in such a way that the vital function of the body is preserved. The eyes are to be specially protected. Unprotected intercourse is permissible for health protection only within the framework of a fixed, exclusive relationship between Master and Slave by mutual consent.

§ 13 PHOTO AND FILM RECORDINGS AND MEDIA CONTROL

The Master possesses the unrestricted right to make photo and film recordings (fetish media, image documents of chastisement and submission) of the Slave at any time. The publication, commercial, or private use of these recordings on the internet or in specific networks lies solely within the free discretion of the Master. Since the Master fully manages the online presence, web design, fan mail, and editing of the Slave's fetish videos, the permanent archiving, utilization, and control of this material falls upon him. A right to deletion or revocation after termination is explicitly excluded.

§ 13B DIGITAL TOTAL SURVEILLANCE

The Slave grants the Master (and the control authorities authorized by him) unrestricted, permanent access to all her digital devices, smartphones, laptops, social media accounts, passwords, e-mails, and messenger histories. She must share her live location digitally at all times without being asked. Secretly deleting histories, using unauthorized apps, or withholding passwords is evaluated as the heaviest refusal of obedience and is punished unyieldingly.

§ 14 TRANSFER OF RIGHTS TO THIRD PARTIES AND LEASE

The Master can temporarily transfer his rights of breeding, education, chastisement, as well as the sexual right of use to third parties or lease the Slave to third parties. The Slave must serve third parties within the framework of this assignment with the same absolute humility, submission, and complainlessness as her Master. In the case of a lease to male third parties, a strict condom obligation applies to protect health, unless the Master explicitly decrees otherwise. Adherence to the safeword (§ 11) and the duty of care (§ 12) must be strictly observed by third parties.

§ 14B COMMERCIAL UTILIZATION AND SEX WORK

The Master possesses the sole and unrestricted right to commercially exploit the Slave's sexual services and use her to generate income. The Slave commits herself to execute sexual acts on and with foreign customers (be it within the framework of prostitution, escort services, or organized meetings) for financial remuneration upon the Master's order. All revenues resulting from this activity belong fully and exclusively to the Master and must be surrendered to him completely. The Slave possesses no right of co-determination regarding the

selection of customers, the requested practices, or the terms of admission, and has to serve every customer with absolute, humble readiness to serve.

§ 15 FINANCIAL EXPROPRIATION AND ALLOWANCE REGULATION

The Slave fully transfers any right to independent wealth, property, and asset accumulation to the Master. All her private accounts, credit cards, savings, and ongoing income (including income from her regular work) are fully managed, disposed of, and monitored by the Master. The Slave receives only a minimal weekly allowance from the Master for absolutely unpostponable purchases of daily necessity. Unauthorized financial expenses or the concealment of cash and assets are considered severe theft of the Master's property and will be punished drakonisch.

§ 16 KÜNDIGUNG UND AUFLÖSUNG / TERMINATION AND DISSOLUTION

(1) By the Slave:

The Slave possesses no independent right to unilateral termination, revocation, or dissolution of the contract. She can only ask the Master in deep humility and submissiveness, stating comprehensible reasons, for a release from slave status. The decision on an eventual release rests exclusively within the free, unappealable, and sovereign discretion of the Master.

(2) By the Master:

The Master can terminate the slave contract at any time, without compliance with notice periods and without giving reasons, without notice, cast out the Slave, or dissolve the contract should she prove unworthy of his rule.

Taboos and limits of the Slave are to be noted here (to be released by the Master): [None / No exceptions released]

EXECUTION OF THE CONTRACT

Both partners conclude this contract in mutual recognition. The contract serves to write in stone the absolute submission of the Slave and the unalterable transfer of ownership to the Master.

Slave's Part:

I hereby promise to belong completely to my Master as a slave, that is, to stand at his disposal continuously and 24/7. I will completely subordinate myself to the desires and wishes of my Master, without being influenced by third parties, and perform my services on behalf of the Master in absolute humility, complainlessness, and diligence. With my signature, I declare that I have understood this contract. I agree and accept all the strict rules in this contract. I am ready to gift my body to my Master, to serve him for his satisfaction, and to belong as his lawful property.

Master's Part:

I have understood this contract and accept the wish of my Slave to serve me. I assume responsibility for her well-being within the scope of confinement, her consistent education and perfection into an absolutely humble, obedient slave. I recognize my property rights and will enforce them unmercifully.
