

ADDENDUM TO THE SLAVE CONTRACT

Appointment and Absolute Transfer of Authority of Co-Mistress Babsi B.

PREAMBLE

This addendum constitutes a direct, legally binding, permanent, and irrevocable extension of the Slave Contract. It regulates the establishment, powers, and absolute transfer of authority to Co-Mistress Babsi B., who is the biological daughter of the Slave Celeste [REDACTED] (globally known under her fetish name "Slut Orgasma Celeste"). The regulations of this addendum possess absolute operative priority and override any deviating or more general formulations of the main contract as soon as the Co-Mistress takes over administration or specific rental sessions. This addendum applies uninterruptedly 24/7 and smashes any remaining familial or psychological spaces of the Slave.

This contract is agreed between:

M. [REDACTED] (hereinafter referred to as **Master** or **Lord**),

Babsi B. (hereinafter referred to as **Co-Mistress**, in her capacity as the biological daughter of the Slave),

and applies directly to and against the Slave **Celeste** [REDACTED] (**Pseudonym: "Slut Orgasma Celeste"**) (hereinafter referred to as the Slave, in her capacity as the biological mother of the Co-Mistress).

§ 1 STATUS, HIERARCHY AND BIOLOGICAL RANKING REVERSAL

(1) The Master remains the supreme owner and the final, absolute authority over the Slave, the Co-Mistress, and the entire structure of rule. All parties involved are bound to absolute blind obedience to him.

(2) Co-Mistress Babsi B. is hereby deployed as the executing and ruling power. If the Master is not present or transfers specific operative areas to her, all rights, full powers, authority to issue directives, and control rights of the Master transfer one-to-one and in full scale to the Co-Mistress. In these areas, the biological daughter is the absolute ruler over her biological mother. Her commands stand on the same unalterable level as those of the Master.

(3) Complete reversal of the biological ranking structure: The Slave explicitly and irrevocably recognizes that the biological mother-daughter relationship between her and Co-Mistress Babsi B. is fully dissolved, devalued, and reversed within the framework of this contract. The biological daughter stands unappealably and miles above her mother in rank. Any rebellion by the Slave invoking her maternal role, her age, or familial ties will be evaluated as the heaviest refusal of obedience against the Master and sanctioned drakonisch.

(4) Ban on maternal articulation: The Slave is strictly forbidden from expressing maternal advice, emotional reproaches, familial familiarities, or educational reprimands toward Co-Mistress Babsi B. Communication from the mother to her daughter must take place exclusively in absolute, reverent humility on her knees, with a lowered gaze, and under utilization of the correct degradation names.

§ 2 OPERATIVE COUPLING TO § 8B AND SPECIALIZATION IN ANIMAL LEASING

(1) Co-Mistress Babsi B. is explicitly specialized within the structure of rule to exploit and rent out her biological mother commercially and privately for the most intensive animal uses to third parties. For this purpose, she is granted the unrestricted, autarkic operative enforcement power over **§ 8b Paragraphs 1–4 of the Main Contract**.

(2) The Co-Mistress possesses the sole right to independently command, organize, and seamlessly monitor the selection of powerful, large-breed dogs, the frequency and duration of the animal sessions, and the ritual preparations (such as the exact smearing of the Slave's intimate zones with biological attractants) in the name of the Master. The Slave has to deliver herself unconditionally to the animal assignments of her biological daughter as a helpless breeding animal on all fours.

§ 3 SURVEILLANCE AND ENFORCEMENT OF THE TOILET PROTOCOL ACCORDING TO § 8C

(1) Co-Mistress Babsi B. is hereby deployed as the direct administrative control authority for the full-scale enforcement of **§ 8c of the Main Contract** during and in the aftermath of the sessions led by her.

(2) She possesses the unrestricted full power to physically demand and monitor the silent, immediate, and residue-free clearing and utilization of all biological remainders of the animals as well as the participating persons purely with the mouth and tongue of her biological mother. Any articulation of disgust or resistance by the Slave is excluded toward her daughter and will be sanctioned immediately by the Co-Mistress with drakonischen educational punitive measures (e.g., the deployment of the shock collar).

§ 4 ABSOLUTE CHASTISEMENT, DRESSAGE, AND TRAINING COMPETENCE BY ALL MEANS

(1) Co-Mistress Babsi B. receives the absolutely unrestricted, free, and independent right to train, dress, and discipline the Slave (her biological mother) at her own discretion, as she wants. All conceivable means, methods, and tools of torment are available to her without any restriction to smash the Slave's pride completely.

(2) This explicitly, unlimitedly, and uncensoredly includes the permanent, disciplinary deployment of a remote-controlled **electronic shock collar** (training collar with a high-frequency electric shock function) around the neck or the intimate zones of the Slave. The Co-Mistress is autarkically authorized to trigger electric shocks of any intensity and duration via remote control to force immediate blind obedience or to physically punish any hesitation instantly.

(3) For the effective preparation and post-processing of the animal assignments as well as for the targeted maximization of the urge-stagnation and psychological availability, the full administrative disposal over **§ 5c of the Main Contract (Cage Keeping)** is transferred to the Co-Mistress. She is autarkically empowered to confine and lock her biological mother before and after the dog sessions for indefinite intervals of time stark naked and bound in the designated, lockable stainless steel cages on the balcony or in the living quarters.

§ 5 FINANCIAL EXCEPTION TO § 14B AND ALLOCATION OF INCOME

(1) In explicit and conscious deviation from § 14b of the Main Contract, it is established that all revenues, proceeds, fees, and financial contributions resulting from the private or commercial leasing of the Slave to foreign customers or for the powerful large-breed dog assignments organized by the Co-Mistress, **belong fully, undividably, and exclusively to Co-Mistress Babsi B.**

(2) All funds from these specialized sessions are to be transferred directly to the Co-Mistress. The Slave possesses no rights or claims to these financial values. Sovereignty over billing remains with the Master for administrative safeguarding.

§ 5B PROHIBITION OF MATERNAL SHAME BEFORE THIRD PARTIES AND SPECTATORS

The Slave is forbidden under drakonischen penalty from showing any maternal protective instincts, familial shame, or bourgeois restraint in the presence of Babsi's customers, spectators, or the owners of the powerful large-breed dogs. She has to act in front of the eyes of her daughter and the foreign men as an absolutely naked, nameless piece of livestock that possesses no claim to respect or familial consideration whatsoever. Her biological role as a mother is completely and irrevocably extinguished before the customers.

§ 5C PROTOCOL OF RITUAL MATERNAL DISEMPOWERMENT AND GENERATIONAL RETALIATION

(1) The Slave recognizes that any form of her former maternal educational authority, guideline competence, or power that she exercised in the past over her biological daughter (Co-Mistress Babsi B.) is hereby retroactively classified as a severe ritual offense against today's ruling order. She loses any right to respect for her biological life achievement as a mother.

(2) Upon the command of the Co-Mistress, the Slave has to crawl on all fours before her biological daughter and deliver a ritual "maternal confession". In this, she has to apologize loudly and under tears for every single reprimand, every ban, and every restriction from Babsi's childhood and youth. The Co-Mistress is unrestrictedly entitled to enforce retroactive, drakonische punishments for these past "offenses" of maternal upbringing using the electronic shock collar or tools of chastisement.

(3) The Slave furthermore has to serve the Co-Mistress as an absolutely rechtlose, aging body-servant. While the Co-Mistress styles and prepares herself for her commercial dog rentals or private outings, the Slave has to function completely naked as a lifeless, silent mirror, as a clothes rack, or as a footstool for the high heels of her daughter. Every condescending gesture, every kick, and every verbal humiliation by the Co-Mistress is to be accepted silently by the Slave in deep gratitude as a just punishment for her bare biological existence.

§ 6 DIGITAL TOTAL SURVEILLANCE AND ISOLATION

Co-Mistress Babsi B. functions as the supreme administrative control authority over her biological mother. She has unrestricted access to her smartphones, laptops, passwords, messenger histories, and live locations.

She is empowered to forbid contacts and to enforce and sanction the absolute social isolation of the Slave at a distance seamlessly.

§ 7 GELTUNGSDAUER UND KÜNDIGUNGSAUSSCHLUSS / DURATION OF VALIDITY AND EXCLUSION OF TERMINATION

This addendum contract remains in force until the Master decrees a change or the withdrawal of the rank of the Co-Mistress. The Slave has no right whatsoever to contest, refuse, or in any way dissolve this addendum contract.
